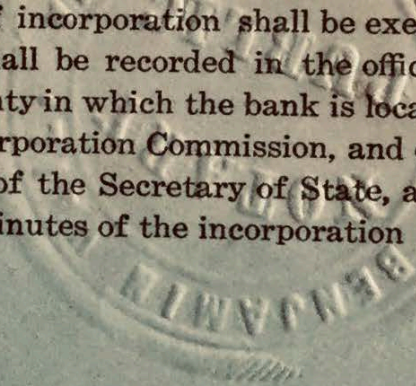

ARTICLES OF INCORPORATION

OF THE

This is to Certify, That we R. L. Watt, R. L. Dixon, J. B. Jones,

J. L. Morton, R. L. Walker, Robt. Hairston, Jas. A. Hurdle,
E. Sims Jr, W. W. Kitchie,

(Not less than three incorporators)

do hereby associate ourselves into a corporation under and by virtue of the provisions of an act of the General Assembly of the State of North Carolina, Session 1903, entitled "An act to revise the laws authorizing the business of banking, and to define the duties of the Corporation Commission in the supervision of the State, Private and Savings Banks of the State, and to provide for the charter of same by the Secretary of State," and do severally agree to take the number of shares of the capital stock set opposite our respective names.

First: The name of the corporation is *Bank of Caswell*

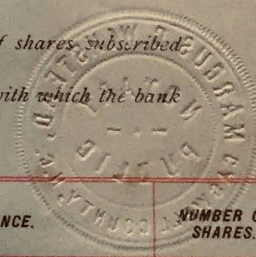
Second: The location of the bank is at No. _____ Street,


