# COMPANY C, "CASWELL RANGERS"

---

This company, originally known as the "Caswell Rangers," was enlisted at Yanceyville, Caswell County, for twelve months service. The original recruits were principally from Caswell County. It was mustered into Confederate States service March 14, 1862, for three years or the war as "Captain H. W. Reinhartt's Company in the Edmondston's Battalion of Cavalry of North Carolina Volunteers." Edmondston's Battalion failed to complete its organization and was never recognized by the Confederate War Department. The activities of the company from the time of organization and muster-in until it was assigned to the 41st Regiment N. C. Troops (3rd Regiment N. C. Cavalry) on September 3, 1862, are not known. On that date it became Company C of that regiment, and the activities of the company after that date are reported as part of the regimental history.

The information contained in the following roster of the company was compiled principally from company muster rolls, which include the muster-in roll dated March 14, 1862, and muster rolls for the period April through October, 1864. No company muster rolls were found for the period from March, 1862, through March, 1864, or after October, 1864. Although there are no Roll of Honor records for this company, useful information was obtained from receipt rolls, medical records, prisoner of war records, and other primary records, supplemented by state pension applications, United Daughters of the Confederacy records, and postwar rosters and histories.

## OFFICERS

### CAPTAINS

\* REINHARDT, HANNON W.

Resided in Caswell County where he enlisted at age 29, February 28, 1862 for the war. Elected Captain on February 28, 1862 and appointed to rank from that date. Present or accounted for until he resigned. Submitted his resignation August 1, 1864 by reason of ill health. Resignation officially accepted September 8, 1864.

HATCHETT, JOHN W.

Resided in Caswell County where he enlisted at age 25, February 28, 1862 for the war. Mustered in as 2nd Lieutenant March 14, 1862 and elected 1st Lieutenant July 18, 1862. Appointed to rank from that date. Promoted to Captain to rank from September 8, 1864. Present or accounted for through February 1865.

### LIEUTENANTS

FARISH, THOMAS WILLIAMSON, 2nd Lieutenant

Enlisted in Caswell County at age 19, February 28, 1862 for the war. Appointed 2nd Lieutenant to rank from date of enlistment. Tendered his resignation by reason of "physical disability" and it was officially accepted August 18, 1862.

HENDERSON, NATHANIEL S., 1st Lieutenant Enlisted in Caswell County at age 24, February 28, 1862 for the war. Appointed 1st, Lieutenant to rank from date of enlistment. Submitted his resignation July 15, 1862 by reason of illness and it was officially accepted July 18, 1862.

RICE, STEPHEN A., 1st Lieutenant

Resided in Caswell County where he enlisted at age 36, February 28, 1862 for the war. Mustered in as Sergeant and elected 2nd Lieutenant August 18, 1862. Appointed to rank from date of election. Promoted to 1st Lieutenant to rank from September 8, 1864. Present or accounted for through October 1864. Admitted to hospital at Raleigh, NC., January 7, 1865 with "rheumatism acute and returned to duty January 12, 1865.

WILLIAMSON, JAMES A., 3rd Lieutenant

Resided in Caswell County where he enlisted at age 21, February 28, 1862 for the war. Mustered in as Corporal and elected 3rd Lieutenant August 28, 1862. Appointed to rank from date of election. Present or accounted for through October 1864 being "absent sick at home" from August 10, 1863 through October 1864.

### NON-COMMISSIONED OFFICERS AND PRIVATES

\*ADAMS, HANNIBAL, Private

Resided in Caswell County where he enlisted July 18, 1863 for the war. Present or accounted for through October 1864.

ADAMS, WILLIAM W., Private

Enlisted in Caswell County at age 50, March 1, 1862 for the war. Present or accounted for through October 1864. Captured on James River, Va., April 23, 1865 and confined at Newport News, Va., until released after taking Oath of Allegiance June 30, 1865.

APPLE, ELISHA L, Private

Resided in Caswell County where he enlisted July 14, 1862 for the war. Present or accounted for through October 1864. Captured near Sussex Court House, Va., December 14, 1864 and confined at Point Lookout, Md., until released after taking Oath of Allegiance June 22, 1865.

BAKER, THOMAS S., Private

Transferred from Captain Andrews' Company Alabama Light Artillery December 12, 1863. Present or accounted for through October 1864. Paroled April 29, 1865.

\*BAKER, WILLIAM M., Private

Enlisted in Lenoir County November 4, 1862 for the war. Present or accounted for through October 1864.

BARROW, JOHN H., Private

Enlisted in Caswell County May 7, 1868 for the war. Present or accounted for through October 1864.

BENNETT, GEORGE D., Private

Enlisted in Caswell County May 14, 1862 for the war. Present or accounted for through October 1864.

BIDSON, TRAVIS, Private

Captured at Harrisonburg, Va., September 25, 1864 and confined at Point Lookout, Md., until exchanged at Coxes Landing, James River, Va., March 25, 1865.

BLANCHARD, F. W., Private

Resided in Alamance County and enlisted in Caswell County October 11, 1862 for the war. Detailed on light duty in Salisbury, N.C., May-June 1864 through October 1864. Present or accounted for until transferred to. Company K, 6th Regiment N.C. State Troops November 7, 1864.

BRINCEFIELD, COLMAN, Private

Enlisted in Caswell County at age 27, February 28, 1862 for the war. Present or accounted for through October 1864.

BURCH, ANDREW J., Private

Born in Person or Caswell County and resided as a farmer prior to enlisting in Lenoir County November 12, 1863 for the war. Captured near Hanover Court House, Va., May 31, 1864 and confined at Point Lookout, Md., where he joined the U.S. service June 27, 1864 and was mustered into Company H, 1st Regiment U.S. Volunteer Infantry at Norfolk, Va., July 22, 1864 for three years service,

BURK, WILEY Mc., Private

Enlisted in Caswell County at age 23, April 17, 1862 for the war. Admitted to hospital at Petersburg, Va., June 20, 1864 with a gunshot wound. Transferred to hospital at Richmond, Va., June 22, 1864 where he died June 27, 1864 of wounds and pneumonia.

CAMPBELL, ALLEN C., Private

Enlisted in Caswell County at age 31, February 28, 1862 for the war. Present or accounted for until transferred to Company H, 6th Regiment N.C. State Troops November 7, 1864.

CARTER, DANIEL L., Private

Resided in Rockingham County. Transferred to Company D, 63rd Regiment N.C. Troops (5th Regiment N.C. Cavalry) January 2, 1865.

CARTER, WILLIS A., Private

Born in Tennessee and resided as a clerk in Caswell County where he enlisted at age 31, March 20, 1862 for the war. Discharged at Kinston, N.C., November 18, 1862 by reason of disability.

CLAYTON, JAMES D., Private

Enlisted in Lenoir County October 14, 1862 for the war. Present or accounted for until retired to the Invalid Corps November 14, 1864 by reason of "rheumatism." Assigned to light duty at Richmond, Va., November 24, 1864.

COBB, MADISON W., Private

Enlisted in Caswell County at age 25, March 5, 1862 for the war. Died in hospital at Richmond, Va., September 18, 1864 of "gangrene."

COMBS, JAMES C., Private

Enlisted in Wake County April 10, 1864 for the war and assigned to this company September 23, 1864. Present or accounted for through October 1864.

DABBS, LEMUEL J., Private

Enlisted in Caswell County at age 30, February 28, 1862 for the war. Wounded in arm and detailed for guard duty at Danville, Va., February 9, 1864. Absent on detail when he was transferred to Company H, 6th Regiment N.C. State Troops November 7, 1864.

DENNY, JOHN R., Corporal

Enlisted in Caswell County at age 20, February 28, 1862 for the war. Mustered in as Private and appointed Corporal May-June 1864. Present or accounted for through October 1864.

\* DENTON, JOHN H., Private

Enlisted in Lenoir County December 3, 1862 for the war. Present or accounted for through October 1864.

DIX, HUGH, Private

Enlisted in Caswell County at age 24, February 28, 1862 for the war. Present or accounted for through October 1864.

DONAHO, WILLIAM A., Private

Enlisted in Caswell County at age 26, March 5, 1862 for the war. Detailed as Teamster and Ambulance Driver February 19, 1863. Present or accounted for through October 1864.

FARISH, JOHN B., Private

Enlisted in Dinwiddie County, Va., October 6, 1864 for the war. Present or accounted for through October 1864. Wounded in action at Five Forks, Va., April 1, 1865.

FAULKNER, JOSEPH T., Corporal

Resided in Caswell County where he enlisted at age 29, March 5, 1862 for the war. Mustered in as Corporal. Present or accounted for through October 1864. Captured at Sussex Court House, Va., December 12, 1864 and confined at Point Lookout, Md., until released after taking Oath of Allegiance June 26, 1865.

FERGERSON, ALEXANDER, Private

Born in Caswell County where he resided as a farmer and enlisted at age 33, March 19, 1862 for the war. Discharged at Danville, Va., March 3, 1863 by reason of "chronic gastritis."

FERRELL, J. A., Private

Died in hospital at Petersburg, Va., August 10, 1863 of "febris typhoides."

FERRELL, JAMES H., Sergeant

Enlisted in Caswell County at age 23, February 28, 1862 for the war. Mustered in as Private and appointed Sergeant prior to July 1863. Present or accounted for through October 1864.

FITZGERALD, A. L., Private

Enlisted in Caswell County May 14, 1862 for the war. Transferred to the Field and Staff of this regiment upon appointment as Ordnance Sergeant July-September 1864.

FOSTER, THOMAS J., Private

Born in Caswell County where he enlisted at age 25, February 28, 1862 for the war. Captured near Goldsboro, N.C., December 17, 1862 and paroled. Deserted and confined at Fort Monroe, Va., October 25, 1863 where he was released October 31, 1863 and sent to Missouri. (Note: Probably became a Galvanized Yankee to fight Indians.)

FOWLER, JOSEPH R., Private

Enlisted in Caswell County at age 16, February 28, 1862 for the war. Present or accounted for through October 1864.

FRETWELL, BARTLETT Y., Private

Resided in Caswell County where he enlisted at age 19, February 28, 1862 for the war. Present or accounted for through October 1864. Captured at Sussex Court House, Va., December 12, 1864 and confined at Point Lookout, Md., until released after taking Oath of Allegiance June 26, 1865.

FULLINGTON, THOMAS J., Private

Enlisted in Caswell County at age 21, March 5, 1862 for the war. Present or accounted for through October 1864.

GIBSON, THOMAS C., Private

Born in Caswell County where he enlisted at age 22, March 5, 1862 for the war. Died December 16, 1862 of wounds received in a skirmish near Trenton, N.C., on December 12, 1862.

GOOCH, DUDLEY, Private

Admitted to hospital at Danville, Va., April 3, 1865 with a gunshot wound.

GROTH, FREEMAN, Private

Paroled at Greensboro, N.C., May 17, 1865.

GUNN, GEORGE W., Sergeant

Previously served as an officer in Company A, 13th Regiment N.C. Troops (3rd Regiment N.C. Volunteers). Enlisted in this company in Caswell County at age 27, February 28, 1862 for the war. Mustered in as Sergeant. No records after muster in.

GWYN, LITTLETON A., Private

Enlisted in Caswell County at age 19, February 28, 1862 for the war. Present or accounted for through October 1864. Paroled April 25, 1865.

GWYN, PINCKNEY, Musician

Enlisted in Caswell County at age 43, February 28, 1862 for the war. Mustered in as Musician. No records after muster in.

GWYN, ROBERT Z., Private

Enlisted in Caswell County at age 22, February 28, 1862 for the war. Mustered in on March 14, 1862. No records after that date.

GWYN, THOMAS R., Private

Enlisted in Caswell County at age 20, February 28, 1862 for the war. Present or accounted for through October 1864.

GWYNN, Z. V., Private

Enlisted in Caswell County May 16, 1862 for the war. Present or accounted for through October 1864.

HALL, JOHN H., Private

Enlisted in Caswell County at age 27, February 28, 1862 for the war. Present or accounted for through October 1864, being absent sick in hospital at Danville, Va., from April 27, 1864 through October 1864. Transferred to the 6th Regiment N.C. State Troops November 7, 1864; however, he was still reported on hospital reports in January 1865 as belonging to this company and regiment.

HAMLET, RICHARD W., Sergeant

Enlisted in Caswell County at age 34, March 3, 1862 for the war. Mustered in as Sergeant on March 14, 1862. No records after that date.

HARRELSON, JAMES, Private

Enlisted in Caswell County July 14, 1862 for the war. Captured at Hanover Court House, Va., May 31, 1864 and confined at Point Lookout, Md. No record of release.

HARRELSON, JOHN F., Private

Enlisted in Caswell County at age 27, March 5, 1862 for the war. Captured and paroled at Kinston, N.C., December 15, 1862. Present or accounted for through October 1864 when he was reported as 'wounded in breast at White Oaks, Va., August 15, 1864.'

HARRELSON, PETER, Private

Born in Caswell County where he enlisted at age 18, March 5, 1862 for the war. Deserted and confined at Fort Monroe, Va., October 25, 1863 where he took the Oath of Allegiance November 5, 1863 and was sent to Missouri. (Note: Galvanized Yankee to Fight Indians out West)

HATCHETT, LUDALPHUS P., Private

Enlisted in Caswell County at age 18, February 1862 for the war. Present or accounted for through October 1864.

HATCHET", THOMAS R., Private

Enlisted in Caswell County at age 38, April 2, 1862 for the war. Mustered in on March 14, 1862, No records after that date.

HINTON, JAMES B., Private

Born in Caswell County where he enlisted at age February 28, 1862 for the war. Mortally wounded in a skirmish near Trenton, N.C., December 12, 1862.

HINTON, NATHANIEL, Private

Enlisted in Caswell County September 16, 1863 for the war. Present or accounted for through October 1864.

HODGES, FIELDEN L., Private

Enlisted in Caswell County at age 17, March 8, 1862 for the war. Captured at Kinston, N.C., December 12, 1862 and paroled. Present or accounted for Paroled April 25, 1865.

HODGES, G. O., Private

Enlisted in Caswell County October 6, 1864 for the war. Killed in action December 10, 1864.

HOOPER, ALLEN J., Private

Enlisted in Caswell County at age 23, February 28, 1862 for the war. Present or accounted for through October 1864.

HOOPER, SIDNEY Y., Private

Enlisted in Caswell County at age 22, February 28, 1862 for the war. Present or accounted for until transferred to Company D, 13th Regiment N.C. Troops (3rd Regiment N.C. Volunteers) November 24, 1864.

HOOPER, THOMAS, Private

Enlisted in Caswell County at age 30, February 28, 1862 for the war. Present or accounted for through October 1864.

HOOPER, WILLIAM P., Private

Born in Caswell County and resided as a dentist prior to enlisting in Caswell County at age 21, February 28, 1862 for the war. Discharged at Tuckahoe, N.C., January 7, 1863 by reason of disability.

HOPPER, WILLIAM A., Private

Born in Edgecombe County and resided as a trader prior to enlisting in Caswell County at age 19, July 12, 1862 for the war. Discharged at Camp Colston, Va., May 26, 1863 by reason of "a fall from his horse, producing disease of the spine and paralysis of the lower extremities."

HORTON, THOMAS J., Private

Enlisted in Caswell County at age 27, February 28, 1862 for the war. Wounded and captured on Plank Road, Dinwiddie County, Va., May 12, 1864 and confined at Elmira, N.Y., until paroled and exchanged at James River, Va., March 18-21, 1865.

HORTON, WILLIAM J., Private

Enlisted in Caswell County July 18, 1863 for the war. Present or accounted for through October 1864.

HOWARD, LEROY W., Private

Enlisted in Caswell County at age 16, April 17, 1862 for the war. Present or accounted for through October 1864.

\* HUBBARD, FREEMAN A., Private

Enlisted in Caswell County September 23, 1863 for the war. Wounded in action at Gaines Farm, Va., June 21, 1864 and admitted to hospital. Furloughed for 60 days July 20, 1864. Present or accounted for through October 1864 as absent wounded.

HUBBARD, JAMES, Private

Enlisted in Caswell County January 7, 1863 for the war. Present or accounted for through October 1864.

HUBBARD, LOWERY, Private

Resided in Caswell County and enlisted September 23, 1863 for the war. "Detailed."

JOHNSTON, NAT L., Private

Enlisted in Wake County January 28, 1864 for the war. Present or accounted for through October 1864.

JOHNSTON, SAMUEL W., Private

Enlisted in Caswell County at age 21, April 2, 1862 for the war. Mustered in on March 14, 1862. No records after that date.

JONES, JAMES M., Private

Resided in Caswell County where he enlisted at age 36, February 28, 1862 for the war. Present or accounted for through October 1864. Admitted to hospital at Raleigh, N.C., December 18, 1864 with a gunshot wound in the right thigh and furloughed for 60 days December 22, 1864.

KENDALL, THEO B., Private

Enlisted in Caswell County June 30, 1862 for the war. Present or accounted for through October 1864, being absent on detail as Commissary Sergeant for the Brigade. Paroled at Greensboro, N.C., April 29, 1865.

KIMBRO, THOMAS K., Private



Born in Caswell County and resided as a farmer prior to enlisting in Caswell County April 8, 1862 for the war. Discharged at Camp Colston, Va., May 26, 1863 by reason of "his age" (48) and "extreme obesity."

LEA, HENRY, Private

Enlisted in Caswell County at age 37, February 28, 1862 for the war. Present or accounted for until retired by Medical Examining Board on July 18, 1864.

LEA, JOHN G., Corporal

Enlisted in Caswell County May 6, 1862 for the war. Appointed Corporal prior to May 1864. Present or accounted for through October 1864.

LEE, JAMES M., Private

Born in Guilford County and resided as a farmer prior to enlisting in Onslow County December 22, 1862 for the war. Discharged at Petersburg, Va., December 19, 1863 by reason of gunshot wound of left arm, fracturing ulna, lower third.

MATLOCK, I. N., Private

Signed pay voucher July 4, 1864 for pay received for the period January 1-April 30, 1864.

MATLOCK, JAMES, Private

Enlisted in Lenoir County November 14, 1863 for the war. Present or accounted for through October 1864.

\* McCAIN, JAMES A., Private

Enlisted in Petersburg, Va., July 13, 1863 for the war. Present or accounted for until transferred to Company A, 13th Regiment N.C. Troops (3rd Regiment N.C. Volunteers) January 23, 1865.

McFARLAND, P. M Private

Enlisted in Caswell County July 18, 1862 for the war. Died in hospital at Richmond, Va., July 31, 1864 of disease.

McKINNEY, JOHN SARTIN, Private

Enlisted in Lenoir County at age 18, April 13, 1864 for the war. Captured at Hanover Court House, Va., May 30, 1864 and confined at Elmira, N.Y. Date of release not given.

MILLER, THEODORE, Private

Enlisted in Northampton County September 10, 1862 for the war. Wounded and captured at Madison Court House, Va., May 28, 1864 and confined at Elmira, N.Y., until sent to James River, Va., for exchange February 20, 1865. Admitted to hospital at Richmond, Va., March 1, 1865 and furloughed for 30 days March 6, 1865. Paroled at Greensboro, NC., May 9, 1865.

MOORE, JOHN W., Private

Enlisted in Caswell County at age 29, April 12, 1862 for the war. Present or accounted for through October 1864. Admitted to hospital at Raleigh, N.C., February 16, 1865 with "febris typhoides and died February 21, 1865.

MOORE, W. W., Sergeant

Enlisted in Caswell County May 10, 1862 for the war. Appointed Sergeant prior to May 1864. Present or accounted for through October 1864.

NASH, FRED M., Private

Born in Caswell County where he resided and enlisted March 8, 1863 for the war. Present or accounted for through October 1864.

NUNNALLY, JOHN H., Sergeant

Enlisted in Caswell County at age 31, February 23, 1862 for the war. Mustered in as Sergeant. Discharged August 21, 1862 at Richmond, Va., by reason of "phthisis pultnionalis."

OWEN, JAMES H., Private

Enlisted in Caswell County at age 32, February 28, 1862 for the war. Mustered in on March 14, 1862. No records after that date.

PARROTT, THOMAS, Private

Enlisted in Caswell County May 12, 1862 for the war. Present or accounted for through October 1864. Paroled at Greensboro, N.C., May 18, 1865.

PAYNE, WILLIAM L., Private

Enlisted in Caswell County at age 37, March 3, 1862 for the war. Present or accounted for through October 1864.

PHILLIPS, BENJAMIN, Private

Born in Orange County and resided as a farmer prior to enlisting in Caswell County at age 40, March 29, 1862 for the war. Discharged at Kinston, NC., December 15, 1863 by reason of "chronic rheumatism of the spine and legs."

PLEASANTS, W. D., Private

Enlisted in Lenoir County January 11, 1864 for the war. Accidentally wounded in the foot June 23, 1864. Present or accounted for through October 1864.

POTEAT, ALLEN, Private

Enlisted in Caswell County May 8, 1862 for the war. Present or accounted for through October 1864.

POTEAT, WILLIAM, Private

Enlisted in Caswell County May 17, 1862 for the war. Present or accounted for through October 1864.

POWELL, HENRY L., Private

Born in Caswell County and resided as a farmer prior to enlisting in Caswell County May 13, 1862 for the war. Killed in action at Trenton, N.C., at age 24, December 12, 1862.

POWELL, J. T., Private

Enlisted in Caswell County July 15, 1862 for the war. Died in hospital at Richmond, Va., August 28, 1864.

POWELL, JOSIAH J., Private

Resided in Caswell County where he enlisted at age 33, February 28, 1862 for the war. Present or accounted for until transferred to Company H, 6th Regiment N.C. State Troops November 7, 1864.

\* POWELL, THOMAS B., Private

Enlisted in Caswell County at age 55, March 25, 1862 for the war. Died in hospital at Petersburg, Va., August 23, 1864 of disease.

PYRANT, ABNER, Private

Enlisted in Caswell County at age 17, March 11, 1862 for the war. Present or accounted for through October 1864.

RAGAN, WILLIAM T., Private

Born in Caswell County where he resided as a farmer and enlisted May 8, 1862 for the war. Discharged May 26, 1863 by reason of "chronic laryngitis and almost entire loss of his voice."

RICE, F. Z., Private

Enlisted in Caswell County at age 16, March 5, 1862 for the war. Present or accounted for through October 1864.

RICE, STEPHEN C., Private

Enlisted in Caswell County at age 18, April 22, 1862 for the war. Present or accounted for until transferred to Company D, 13th Regiment N.C. Troops (3rd Regiment N.C. Volunteers) November 24, 1864.

RICE, THOMAS G., Private

Enlisted in Caswell County at age 47, February 28, 1862 for the war. Present or accounted for through October 1864.

RICHMOND, JOHN M., Private

Resided in Caswell County where he enlisted at age 25, March 5, 1862 for the war. Deserted and entered Federal lines at New Bern, N.C., and was confined at Fort Monroe, Va., March 27, 1864 and released March 31, 1864 and sent to St. Louis, Missouri. Took Oath of Allegiance April 1, 1864. (Note: Could have become a Member of the Galvanized Yankees Sent West to Fight Indians)

ROBERTSON, GREEN, Private

Resided in Caswell County and enlisted in Onslow County January 23, 1863 for the war. Wounded in right foot at White Oak Swamp, Va., August 15, 1864 and furloughed for 60 days August 29, 1864.

ROBERTSON, JAMES M., Private

Enlisted in Caswell County at age 28, March 8, 1862 for the war. Present or accounted for through October 1864 being absent on detail as teamster in 1863 and 1864.

RUDD, JAMES C., Private

Enlisted in Caswell County at age 27, March 3, 1862 for the war. Present or accounted for through October 1864.

SAUNDERS, JAMES MADISON, Private

Enlisted in Caswell County at age 30, February 28, 1862 for the war. Present or accounted for through October 1864.

SAUNDERS, JESSE R., Private

Enlisted in Caswell County at age 42, March 5, 1862 for the war. Detailed as teamster March 6, 1863 and reported as such through October 1864.

SAUNDERS, WILLIAM L., Private

Enlisted in Caswell County at age 23, February 28, 1862 for the war. Present or accounted for through October 1864.

SCALES, C. H., Private

Paroled at Greensboro, N.C., May 16, 1865.

SCOTT, JOHN W., Private

Resided in Caswell County where he enlisted at age 38, February 28, 1862 for the war. Present or accounted for through October 1864. Admitted to hospital at Raleigh, N.C., December 18, 1864 with a gunshot wound in the left arm and shoulder. Furloughed for 60 days December 19, 1864.

SHELTON, WILLIAM C., Private

Enlisted in Caswell County at age 30, March 19, 1862 for the war. Appears on muster in roll dated March 14, 1862. No records after that date.

SIDDLE, JOHN B., Private

Enlisted in Caswell County July 14, 1862 for the war. Present or accounted for through October 1864.

SLADE, EZEKIEL B., Sergeant

SMITH, J. M., Private

Born in Orange County and resided as a farmer prior to enlisting in Caswell County March 6, 1863 for the war. Discharged at Camp Colston, Va., May 26, 1863 at age 36, by reason of "chronic rheumatism."

STEPHENS, A. S., Private

Paroled at Greensboro, N.C., May 1865.

STEPHENS, GEORGE D., Private

Enlisted in Caswell County May 9, 1862 for the war. Present or accounted for through October 1864.

STEPHENS, J. A., Private

Enlisted in Lenoir County November 14, 1863 for the war. Present or accounted for through October 1864.

STEPHENS, MADISON, Private

Born in Caswell County and resided as a farmer prior to enlisting in Caswell County May 9, 1862 for the war. Discharged at Kinston, N.C., December 15, 1863, at age 18, by reason of "a wound received in thigh, rendering his leg perfectly useless."

STOKES, ALVIS H., Private

Enlisted in Caswell County at age 17, March 19, 1862 for the war. Accidentally wounded in foot May 31, 1864. Returned from hospital September 11, 1864 and detailed to get horse September 24, 1864. Returned to company October 19, 1864. Present or accounted for through October 1864.

\* STOKES, JAMES T., 1st Sergeant

Enlisted in Caswell County July 11, 1862 for the war. Appointed O. Sergeant prior to May 1864 and promoted to 1st Sergeant July-August 1864. Present or accounted for through October 1864.

SWANN, JOHN M., Private

Enlisted in Caswell County at age 34, March 5, 1862 for the war. Present or accounted for through October 1864. Paroled May 1, 1865.

TATUN, HAMILTON, Private

Paroled at Greensboro, N.C., May 13, 1865.

TRAVIS, R. W., Private

Resided in Caswell County where he enlisted March 3, 1863 for the war. Present or accounted for through October 1864 when he was reported as "teamster for Division Ordnance Train. No horse." Admitted to hospital at Raleigh, N.C., February 23, 1865 with "rheumatismos chronic" and returned to duty February 27, 1865.

TURNER, GEORGE D., Private

Enlisted in Caswell County at age 23, March 5, 1862 for the war. Mustered in on March 14, 1862. No records after that date.

WALTERS, JACKSON, Private

Enlisted in Caswell County at age 27, March 5, 1862 for the war. Present or accounted for through October 1864.

WALTERS, THOMAS C., Private

Enlisted in Lenoir County November 14, 1863 for the war. Killed in action December 10, 1864.

WARE, THOMAS R., Private

Born in Caswell County where he resided as a farmer and enlisted at age 23, March 5, 1862 for the war. Discharged at Danville, Va., October 22, 1862 by reason of "dyspepsia and predisposition to tuberculosis."

WARINER, THOMAS W., Private

Enlisted in Caswell County at age 17, March 5, 1862 for the war. Present or accounted for through October 1864.

WARREN, JAMES M., Private

Enlisted in Caswell County at age 44, March 5, 1862 for the war. Present or accounted for until transferred to Company D, 13th Regiment N.C. Troops (3rd Regiment N.C. Volunteers) November 24, 1864.

WATLINGTON, JAMES J. B., Private

Enlisted in Caswell County at age 27, March 5, 1862 for the war, Present or accounted for through October 1864. Ordered transferred to the 6th Regiment N.C. State Troops on November 7, 1864; however, it appears that he did not transfer as he was paroled on April 29, 1865 as a member of this company and regiment.

WATLINGTON, JAMES S., Private

Enlisted in Caswell County at age 25, March 5, 1862 for the war. Mustered in on March 14, 1862. No records after that date.

WATLINGTON, JOHN B., Private

Enlisted in Caswell County at age 21, February 28, 1862 for the war. Applied for transfer to the Commissary Department in August 1862. No record after that date.

WATLINGTON, JOHN B., Private

Transferred from Company F, 19th Regiment N.C. Troops (2nd Regiment N.C. Cavalry) January 2, 1865.

WATLINGTON, JOHN H., Private

Enlisted in Caswell County July 14, 1862 for the war. Admitted to hospital at Petersburg, Va., June 20, 1864 with a gunshot wound. Present or accounted for until transferred to Company F, 19th Regiment N.C. Troops (2nd Regiment N.C. Cavalry) January 2, 1865.

WATLINGTON, JOSEPH A., Private

Born in Caswell County where he resided as a farmer and enlisted at age 28, March 5, 1862 for the war. Discharged at Kinston, N.C., December 15, 1863 by reason of "ulcers of the leg."

WATLINGTON, WILLIAM H., Private

Enlisted in Caswell County at age 23, February 28, 1862 for the war. Present or accounted for until transferred to Company F, 19th Regiment N.C. Troops (2nd Regiment N.C. Cavalry) October 16, 1864.

WEST, ROBERT J., Private

Enlisted in Caswell County at age 36, February 28, 1862 for the war. Present or accounted for through October 1864.

WHITE, JAMES F., Corporal

Enlisted in Caswell County at age 24, March 5, 1862 for the war. Mustered in as Private and appointed Corporal prior to May 1864. Present or accounted for through October 1864.

WHITLOW, PLEASANT A., Private

Resided in Caswell County where he enlisted March 5, 1862 for the war. Mustered in as Musician and reduced to Private prior to May 1864. Present or accounted for until transferred to Company H, 6th Regiment N.C. State Troops November 7, 1864.

WILLIAMS, RALPH D., Private

Enlisted in Caswell County October 18, 1864 for the war. Present or accounted for through October 1864.

WILLIAMSON, GEORGE O., Private

Resided in Caswell County where he enlisted at age 18, March 5, 1862 for the war. Admitted to hospital at Danville, Va., June 12, 1864 with a gunshot wound and returned to duty July 7, 1864. Present or accounted for through October 1864.

WILLIAMSON, R. H., Private

Enlisted in Caswell County February 6, 1863 for the war. Present or accounted for through October 1864.



WILLIS, THOMAS, Private

Enlisted in Northampton County July 13, 1863 for the war. "Wounded."

WOMACK, AZARIAH G., Sergeant

Born in Caswell County where he resided and enlisted at age 24, February 28, 1862 for the war, Mustered in as Corporal and appointed Sergeant prior to May 1864. Present or accounted for through October 1864.

WOMACK, RUFUS YANCEY, Private

Previously served in Company I, 5th Regiment N.C. State Troops. Enlisted in this company in Lenoir County February 9, 1863 for the war. Present or accounted for through October 1864. WOODY, WILLIAM J., Private

Enlisted in Caswell County at age 40, March 5, 1862 for the war. Present or accounted for through October 1864.

YANCEY, JAMES M., Private

Enlisted in Caswell County at age 50, April 22, 1862 for the war. Present or accounted for through January 16, 1864 when he received pay for the period August 31-December 12, 1863.
