Descendants of Robert Stanfield

Generation No. 1

1. ROBERT¹ STANFIELD¹ was born 11 Mar 1729, and died 1811 in Halifax County, Virginia. He married ELIZABETH LOWRY.

Notes for ROBERT STANFIELD:

The Stanfields are descended from the ancient Stanfield Family of Britain. The name is Norman and one of the oldest surnames. Yorkshire is the place where the name is first recorded in Britain. Their lands were granted to them by William, the Duke of Normandy for their distinguished service at the Battle of Hastings in 1066 A. D. The family is part of the Vikings who landed on the Orkney Islands and Northern Scotland in about 870 A. D. The name appears in the Domesday Book which is a census of most of England at that time.

There are around forty variations in the spelling of the Stanfield name: Stanfeld, Stansfield, Stansfield, as well as Stanfield. Jordan Stansfield was the first Lord of Stansfield in the valley of Todmorden and was the son of Wyons Maryons. His son was John who was succeeded by Richard, then Edmund, Ralph, Henry, William, then Thomas in the 14th century. His grandson named Thomas acquired Heptonstall in 1508. Then his grandson acquired Sowerby in 1587.

When the migration began to America, the Stanfields were among them. There were several early Virginia Stanfields. Symon Stanfield was listed as immigrating to Virginia by Captain Adam Thoroughgood in 1635 possibly on the Jon & Dorothy, 1634. He was one of 105 persons who were brought in by the captain who received 5,350 acres in Princess Anne County for his efforts. Lawrence Stanfield was recorded as immigrating in 1646 by Elizabeth and Ratchell Robins in Northampton County. The majority of the early Stanfields in Virginia seem to have been located in Halifax County.

The Halifax County, Virginia will of Robert Stanfield:

In the name of God amen. I Robert Stanfield of the County of Halifax being aged and infirm of body, but of a sound mind and memory and caling to mind that it is appointed for men once to dye do make constitute and ordain this and no other to be my Last Will and testament in manner and form following Viz First my will and desire is that all my Just debts should first be paid by my Executors hereafter named. 2nly. I lend to my Beloved wife Elizabeth the tract of land I now Live on with all the Improvements thereon to be by her possesed and enjoyed during her natural Life with the following slaves to witt, Julyous, George, Peter, Bob, Cloe, Winey and amey together with her choice of one mare and two horses and as many of my cattle, hogs, and Sheape as she may Choose to Keep or deam nessesary for her support and mentainance for which she shall be her own Judge together with all my Beds & furneture house hold an Kitchen furneture of Every discription plantation tools and utensels thereunto belonging any ways appertaining together with all my crop Groing on the plantation at the time of my death as laissed in for family consumption and if she Chooses to share any part of the crop or other thing growing or made at the time of my death whether of stock or other thing, my will and desire is that my Executors shood Sell the same and apply the amount of such sale towards the payment of debts discharging Legaseys or ? 3rdly I give and bequeath to my Grand Children sons and daughters of my daughter and Chambers descendants viz as followeth as to Joseph Chambers four pounds sixteen shillings and nine pence and to Thomas Chambers four pounds sixteen shillings and nine pence and to James Chambers four pounds sixteen shillings and nine pence and to Nancy Chambers four pounds sixteen shillings and nine pence having before delivered the same amount to Each of those other Brothers and sisters to make them Eaqual with one another as also Euaqual in their divisions with my own sons and daughters also I give and bequeth to Robert Chambers two negroes two negraces viz Rose and her child which he now hath in possession. I also Give and bequeth to Betsey Standfield the wife of Robert G. Standfield one negro girl named Liz which they also hath in possesion. I also give and bequeth to William Chambers one negro boy named Solemon which he also hath in possession I give and bequeth to Jeney Holt the wife of Hirum Holt one negro boy named Essen which they have in Possesion I give and bequeth to my Grand Children to John, Josiah, Thomas, James & Henry the following slaves viz Tebey, Titus, Mary, Jemmima, Silvey and Florey and their? increase to them and their heirs for ever to be hired out by my Executors until the year Eighteen hundred and eithteen and then Euaqualy divided as before is sayd them their hire and increase and if any of my above named five GrandChildren should Dye before 1818 my will and desire that the survivors of

them and their heirs shood secure to and inherit the dead Child or childrens part. I give and bequeth to all the children of my dec'd Daughter Jane Murey viz Robert, William, James, Nancey, Betsy, and Vincent the sum of one hundred and forty four pounds thirteen shillings current money of Virginia to be Euaqualy divided amongth them as they Come of age or mareys and if any of them should dye before coming of age or mariage to Receive the Legasey herein bequathed that then their share or shares to be euaqualy divided amoungth the survivors of them and their heirs. I give and bequeth to my five Gran Children viz Patsey Lester the wife of Goerge Lester, Joseph Standfield, Robert Standfield, and William Standfield being children sons and Daughters of my dec'd son William Standfield the sum of one hundred pounds current money of Virginia to be divided Euaqualy amongth and Every of them as they come of age or mareys by for and Ecaqual divisions and if any of them should dye before they shood be Entitled to their part my will and desire is that their share shoud be Euaqualy divided amongth survivors of them and there heirs. And lastly my will and desire is that after the death of my wife Elizabeth that the negroes and all other Estate Lent her in this will shall be Euaqualy divided amongth all my Children that is Living and that the heirs of of any of my Children that is or shall be dead at the time of this division shall Succeed to and enjoy the part that would have falen to his father or mother as the Case may be had they been Living and such part as falls to my daughter Elizabeth Posey I only Lend her for life and after her death my will and desire is that the same should be Euaqualy Divided amongth all her children male and female and heirs of the dead if any and if an Euaqual division Cannot be made my will and desire is that my Executors Sell all and every article or thing and make such divisions and Render to Each Lagatee of his share or part. and Lastly I nomenate Constitute and appoint my two sons John and Robert hole and sole Executors of this my Last will and Testament Revoking all others by me heretofore made. Signed sealed and published this 28th day of Augt. 1811 Before us: Tho's Watkins, Sr., John P. Chambers, M Wilson, Tho's Chambers signed Robert Standfield his mark

At a court held for Halifax County the 25th day of November The within written will and testament of Robert Stanfield deceased was exhibited in Court and proved by the oaths of two witnesses thereto subscribed and ordered to be Recorded and on motion of John Stanfield one of the Executorstherein named who made oath thereto according to law certificate is granted him for obtaining probate thereof in due in for and he giving secured whereupon he together with Joseph Standfield, John P. Chambers and Thomas Chambers his securities entered into and acknowledged their bond in the penalty of five thousand Dollars consituted as the law directs for that purpose. Liberty being reserved to the other executor therein named to join in the probate thereof when they shall think pet * 1824 Aug 26 Probate granted

2. WILLIAM² STANFIELD (*ROBERT*¹) was born Bef. 1770 in Halifax County, Virginia, and died 1803 in Person County, North Carolina. He married ELIZABETH BEADLES 14 Dec 1789 in Virginia, daughter of JOSEPH BEADLES. She was born 1770 in Virginia³, and died 25 Nov 1857 in Henry County, Georgia.

Notes for WILLIAM STANFIELD:

We find the widow Elizabeth Stanfield in Oglethorpe County, Georgia in the 1820 Census. The first record of a Stanfield in that county was that of Benjamin Stanfield who signed as a witness to a land sale in 1799. The sale was proved in June 1801. The record is in Deed Book D, 1800-1806, Oglethorpe County, Georgia. There is an Estate File in the same county for a William Stanfield in 1826. There is a Richard Stanfield in Clarke County in the 1810 Tax Digest. There was a listing of a Samuel Stanfield on the accounts of George Vest, deceased in 1799.

Notes for ELIZABETH BEADLES:

A will by Joseph Beadles written on 2 november 1813 and recorded 9 February 1814 in Oglethorpe County, Georgia Will Book B leaves property to his son William, his grandson Joseph, a daughter Patsy Dillard, and a daughter Elizabeth Stanfield. He gave all his negroes to his son William: Frank, Sam, George, Ambrose, Rumsey, Daniel, Patrick, Larkin, Willy, Fellis, Pat, and Cynthia. William also got all the land, 262 acres, they were presently farming and various other household things. Joseph Beadles recieved a mare. The remainder of the property was sold at auction and Patsy got one-third and Elizabeth got two thirds of the money. In the 1820 Census Elizabeth Stanfield is living in Lexington, Oglethorpe County, Georgia as head of the household.

On page 113 Oglethorpe County, Georgia, 9 March 1819, there is a document of Elizabeth Stanfield to make William B. Stanfield, both of said county, my lawful attorney, to sign my name to a note as security for George Lester to the balance of debt due to William Elkins as guardian for the orphans of James Garret, deceased, which debt is now in suit and to act in said case as I could. It was signed by Elizabeth Stanfield. Test: Joseph Stanfield, Faney (signed with an X) Steavens. Oglethorpe County power of Attorney proved by Joseph Stanfield who saw Faney Stevens witness, 9 March 1819. G. Hudspeth, J.I.C. Recorded 15 March 1819, Isaac Collier, clerk. Joseph Stanfield later sued George Lester and Elizabeth Stanfield for a debt. The court found for the plaintiff five hundred and fifty dollars with interest and costs. John Felton was foreman.

On 31 December 1829, Henry County, Georgia Deed Book G Elizabeth bought 101&1/4 acres of lot #58 in District 3 for the sum of \$500 from Lewis Hobgood. It was recorded on 19 July 1834.

In the 1830 Census she has 10 slaves and has one small female child living with her. Her son Joseph and his family is living nearby.

On October 12, 1834, Deed Book G page 196, Elizabeth Stanfield appointed her son William B. Stanfield as her lawful attorney.

The 1850 Census shows Elizabeth as 80 years old and that she was born in Virginia in 1770. She was living with C. Stanfield a female born in 1833 in Georgia. Her marriage bond was in Caswell County, North Carolina. She moved there with her family from Halifax County, Virginia. She and William must have known each other in Virginia and he came to North Carolina to marry her. They lived in Virginia in the early years of their marriage since the 1850 Census gives Elizabeth's birth state as Virginia and of her two sons, Virginia as well. William B. was still alive for that census and Joseph's son stated his father was born in Virginia on a later Georgia census. In Henry County Register of Sales, Book C, 1839-1858, there was a sale of the property of Elizabeth Stanfield, deceased, on 26 November 1857, by William B. Stanfield, administrator which was worth \$803.67. Listed was livestock, saddle, running gear, household and kitchen furniture, provisions, bed clothes, 1 lot of cotton seed at 10 cents a bushel.

Marriage Notes for WILLIAM STANFIELD and ELIZABETH BEADLES: Josias Chambers was the bondsman.

5. JOSEPH³ STANFIELD (*WILLIAM*², *ROBERT*¹) was born 1795 in Virginia. He married ELIZABETH REYNOLDS 16 Feb 1822 in Oglethorpe County, Georgia, daughter of JOSIAH REYNOLDS and ELIZABETH BARBER.

Notes for JOSEPH STANFIELD:

On 14 October 1833, Henry County Deed Book F, Joseph Stanfield gave William B. Stanfield \$5 as payment on a promissory note made by William B. Stanfield and Elizabeth Stanfield for the sum of \$600. Land in District 3, lot #75, 202 & 1/2 acres;a Negro woman named Mary, about 30 years old; and a Negro girl named Silvey, about 14 years old with dark complexion were the security. Witnesses were Francis Pearson and Jesse Johnson J.I.C. The note was recorded on the same day.

Henry County Deed Book G, recorded 14 April 1835, A ruling was made by the Superior Court of Henry County, John B. Reid against John W. Payner, Hyram M. Jackson and Joseph Stanfield in favor of Reid. The property of Joseph Stanfield was seized and sold at public outcry. George W. Reynolds was the highest bidder and the property was knocked off to him for the sum of \$18. Witnesses were T. S. Crawford and James Love, Sheriff.

This author has not investigated the events leading up to the sale of Joseph's property. The Reynolds who bought his property was his wife's brother. George W. Reynolds is listed as one of Margaret Barber's grandsons. I suppose he bought the property to keep Joseph from losing it at auction. Joseph may have been living with his mother in 1840 since there is a female age 70 to 80 living with the family. Or he may have recovered the property and she was living with him. I did not search the location of the property. He is not found after the 1840 Census. His wife Elizabeth must have died between the census times also because she is not found either. There is a young child found living with the older Elizabeth Stanfield in the 1850 Census. I suspect that she is the youngest child of Joseph since his mother is probably the 70 to 80 year old female living with him in the 1840 Census. The fact that Abner is living next door to Elizabeth leads me to speculate that he is another of the children of Joseph.

I have also placed Martha in this family due to the records of the Lester Family.

Notes for ELIZABETH REYNOLDS:

Elizabeth's grandmother was Margaret Barber as we see by the giving of the slave girl Silvey to Elizabeth Stanfield her granddaughter. Later we see Joseph using this same slave as security on the note to his brother William and his wife Elizabeth.

The following is an extract of a will by Margaret Barber of Henry County, Georgia in Wills and Bonds which she signed on 13 October 1829.

I, Margaret Barber make this my last will and testament. To my beloved grandson, Josiah Reynolds, one Negro man named Mat and one Negro woman named Rhoda and her child, Margaret wife of Mat, and one Negro buy named Burton, also livestock and land. To my beloved granddaughter, Margaret Barber, daughter of my son Robert Barber, I give her one Negro girl, Sarah Ann. My son George, to his daughter Margaret Barber one Negro girl named Sinther. To grand daughter, Sarah Johnson, one Negro girl, Clara, To granddaughter Elizabeth Stanfield, one Negro girl, Sylva. To my grandson, George W. Reynolds, one Negro woman Tempy and her child, Rachel. To grandson Josiah Barber, one Negro boy Crawford. To grandson Wadkins Reynolds, one bed, furniture, and bay horse. Witness Murrell Brissin.

In Wills and Bonds of Henry County 1822-1834, page 194, Spenser Reynolds, G. W. Reynolds and Joseph Stanfield were bound for 7,000 dollars for the condition that Spenser Reynolds administer the goods, Chattles and credits of Jason Reynolds, deceased, to make a true and perfect inventory of his estate. This bond was recorded on 8 May 1833 in Henry County.

Henry County Deed Book H, recorded on 18 December 1837, was the sale of 150 acres on the west half of lot #71, District 3 (Editors note: this is near the property Elizabeth Stanfield bought in 1829.) by James Cox of Muscogee County to Joseph Stanfield on 4 February 1832, for the sum of \$750. Witnesses were James S. Fitner and Robert D. Wyche, J.P.

There are records of several Barbers in Lexington, Oglethorpe County, Georgia in the 1820 census: George, Jesse and Mathew. There is also a record of a Barber Reynolds in Texas in the 1880 Census who was born in Georgia and whose father was born in Virginia, although he wasn't found in the records of the family of Elizabeth Reynolds. Thanks to Margaret's will we have the names of her children and some of her grand-children.

Marriage Notes for JOSEPH STANFIELD and ELIZABETH REYNOLDS:

The marriage record in Oglethorpe County mistakenly listed Joseph as Stanford instead of Stanfield.

Notes for WILLIAM B. STANFIELD:

While living in Oglethorpe County, William B. Stanfield applied for a liquor license in 1824 and 1825. The Henry County Deed Book B shows a deed of sale from Joseph Creal to William B. Stanfield of Oglethorpe, Georgia on 5 January 1828 of land in District # for \$800. The land joined that of John Todd. The deed was recorded on 31 January 1828 and witnessed by Joseph Stanfield and Henry Johnson J.P.

The Henry County Deed Book C/D shows the record of sale of 202 & 1/2 acres in lot #175 in District 8 on 20 December 1828, from James S. Johnson to Jack A. Johnson of Oglethorpe County for the sum of \$100. This acreage joins that of James Brown where W. Upchurch now lives. Witnesses were William Hardin, clerk; Byron Hood; Lewellyn Morgan J.P.; William B. Stanfield and Elizabeth Stanfield. The deed was recorded on 22 December 1828.

In the Henry County Deed Book H there is another sale to William Stanfield. John L. Porter of Warren County sold to William B. Stanfield on 2 November 1837 202 & 1/2 acres, lot #223 for \$250. The land was surveyed on 16 August 1821, by James Watson, surveyor and granted to the Said William B. Stanfield by John L. Porter on 2 November 1837. Witnesses were Andrew Henderson J.P., J. C. Campbell and William Segur. The deed was recorded on 8 January 1838.

He married (2) ELIZABETH BARNES 30 Dec 1861 in Chambers County, Aabama⁵. He married (3) Mary J. McKnight 13 Oct 1871 in Chambers County, Aabama⁵. She was born 30 Apr 1830, and died 13 Jan 1923.

Notes for ABNER L. STANFIELD:

Abner's grave is in the middle of the North end of the Darien Cemetery in a large family plot. On the left is Lucinda Frances Stanfield Carter. On the right is a large vault which is probably that of his first wife. Also buried here are two other daughters, Becky and Emma and their husbands.

Notes for MARTHA E. STANFIELD:

In Henry County, Georgia Deed Book F page 104, on February 22, 1832, Elizabeth Stanfield for the love and affection for her grandchildren gave a Negro girl named Rogette about 13 years old to her daughter, Martha D. Lester and her husband George Lester. Witnessed by Joseph Stanfield. For this reason I have placed Martha as the daughter of Joseph Stanfield. She named her second son William B. Lester and that was probably in honor of her grandfather.

Notes for GEORGE LESTER:

He listed both of his parents as being born in Virginia in the 1880 Census. His occupation was County Clerk and he had over 6,000 acres in 1860 with 10 slaves. He was living in Lexington, Oglethorpe County, Georgia in the 1880 Census.
